I /We (referred to as the “Contractor”) in consideration of the services, works or other activities provided by the Contractor to the Association, hereby expressly covenants and agree with Darlington State School P & C Association (referred to as the “Association”) to indemnify and keep indemnified its officers, employees, volunteers, members and agents from and against all actions, claims, demands, costs and expenses (including costs of defending and settling the action, claim or demand) made, sustained brought or prosecuted in any manner based upon, occasion by or attributable to any injury (including death) or any loss or damage to property or financial loss to or suffered by any person (and whether that person is a servant, agent, independent contractor, volunteer, licensee or invitee of the Association or otherwise, which may arise from or in connection with the services, works or any other activities provided by the Contractor, their servants, agents, officers, employees and associates (other than arising out of or in connection with the negligent acts, omissions or errors of the Association).

Furthermore, the above clause shall be relevant with regard to the use of electrical cords and electrical connection, the Contractor agrees and accepts that using a 10 - 15 amp cord adaptor which has not been electrically tested and certified, has the potential to cause risk and/or damage to property and also applies to the use of electricity and connection of any leads and appliances. The Contractor shall be solely responsible for any damage caused to person or property as a result of using electrical connections at the Darlington State School and Darlington Community Markets and agrees to wholly and solely bear the financial burden of any such damage.

This will serve as a record for the stallholder for the year designated and for the stall and product outlined in disclaimer only. If stallholder changes product or has multiple stalls a disclaimer for each stall or variation must be signed.
